

Dashlane T-Shirt Giveaway: Official Contest Rules

- No Purchase Necessary. A purchase does not enhance your chance of winning.
- Eligibility: This contest is open only to those who complete the survey on our blog and who are 18 years of age or older as of the date of entry. The contest is only open to legal residents of The United States of America and is void where prohibited by law. Employees of Dashlane, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in this contest.
- Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Dashlane as final and binding as it relates to the content of this contest.
- Only one (1) entry per survey completion. Duplicate surveys will automatically be disqualified.
- Survey opens September 21. Entries will be accepted online starting on October 1 at 12 am EST and ending October 28 at 12 pm EST. All contest entries must be received by October 28 at 12 pm EST.
- How to Enter: The contest must be entered by submitting an entry using the online SurveyMonkey form provided at <http://blog.dashlane.com/national-cyber-security-awareness-month-2016/>. The entry must fulfill all contest requirements, as specified, to be eligible to win a t-shirt. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Dashlane. You can only enter once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Dashlane.
